Destroying Evil Altars in Your Bloodline and Nation!

I. The Law of Dominion & Territory

“ Then God said, ‘ Let Us make man in Our image, according to Our likeness; let them have dominion over the fish of the sea, over the birds of the air, and over the cattle, over all the earth and over every creeping thing that creeps on the earth.’ So God created man in His own image; in the image of God He created him; male and female He created them. Then God blessed them, and God said to them, ‘ Be fruitful and multiply; fill the earth and subdue it; have dominion over the fish of the sea, over the birds of the air, and over every living thing that moves on the earth.’ ” (Genesis 1:26– 28, NKJV)

A. **The Law of Dominion and Territory** simply states that “ spirits without physical bodies of dirt are illegal on earth” unless they are functioning through a human. This is an unbreakable law of God’ s Kingdom.

B. Anchor Scriptures on the Law of Dominion & Territory

“ The heavens are the heavens of the Lord, but the earth He has given to the children of men.” (Psalm 115:16, NKJV)

“ Assuredly I say to you, whatever you bind on earth will be bound in heaven, and whatever you loose on earth will be loosed in heaven. Again, I say to you that if two of you agree on earth concerning anything that they ask, it will be done for them by My Father in heaven.” (Matthew 18:18– 19)

C. The Law of Dominion & Territory Key Statements:

1. The Law of Dominion made EARTH into the World of Men!
2. God Builds an INTERFACE. Altars are portals between two worlds.

“ And Noah built an altar to the Lord and took of every clean [four-footed] animal and of every clean fowl or bird and offered burnt offerings on the

altar. When the Lord smelled the pleasing odor [a scent of satisfaction to His heart], the Lord said to Himself, I will never again curse the ground because of man, for the imagination (the strong desire) of man's heart is evil and wicked from his youth; neither will I ever again smite and destroy every living thing, as I have done.” (Genesis 8:20–21)

II. Defining an Altar

A. An altar is a portal or place of exchange where spirits (God, angels, or demons) land. It is where humanity meets with divinity.

B. An altar also functions as a:

1. A supernatural landing strip
2. A meeting place
3. A power station
4. A platform
5. A consecrated place
6. A place of exchange

C. Altars are also divine systems of authorization for covenants, promises, and rituals.

D. Altars are NEITHER Old nor New Testament Teaching. They are ANCIENT PATHS (Timeless principles; from the Hebrew word “Olam” which don't change with time).

For example:

1. The Law of Gravity
2. The Law of Redemption
3. The Law of Honor

Altars are so transcendent they are found both in Heaven and on Earth.

E. Two Types of Altars

“ And in the course of time Cain brought to the Lord an offering of the fruit of the ground. And Abel brought of the firstborn of his flock and of the fat portions. And the Lord had respect and regard for Abel and for his offering, but for Cain and his offering, He had no respect or regard. So, Cain was exceedingly angry and indignant, and he looked sad and depressed.” (Genesis 4:3–5)

1. Godly or righteous altars
2. Evil Altars

F. **Two Dimensions of Altars**

1. Mobile altars
2. Stationery Altars

G. **Key Statement:** All altars are raised by a sacrifice and sustained by a sacrifice!

“ Then the king said to Araunah, ‘ No, but I will surely buy it from you for a price; nor will I offer burnt offerings to the Lord my God with that which costs me nothing.’ So David bought the threshing floor and the oxen for fifty shekels of silver. And David built there an altar to the Lord, and offered burnt offerings and peace offerings. So the Lord heeded the prayers for the land, and the plague was withdrawn from Israel.” (2 Samuel 24:16– 25, NKJV)

H. **Key Statement:** The only place where we can fully destroy an altar is in the courts of heaven!

This is because altars are legal entities in the spirit world and so only a court of law can fully destroy their power and end their demonic reign in our lives.

“ And behold, there came a man of God out of Judah by the word of the Lord to Bethel. Jeroboam stood by the altar to burn incense. The man cried against the altar by the word of the Lord, ‘ O altar, altar, thus says the Lord: Behold, a son shall be born to the house of David, Josiah by name; and on you shall he offer the priests of the high places who burn incense on you, and men’ s bones shall be burned on you.’ And he gave a sign the same day, saying, ‘ This is the sign which the Lord has spoken: Behold, the altar shall be split and the ashes that are upon it shall be poured out.’ When King Jeroboam heard the words the man of God cried against the altar in Bethel, he thrust out his hand, saying, ‘ Lay hold on him!” And his hand which he put forth against him dried up, so that he could not draw it to him again. The altar also was split, and the ashes poured out from the altar according to the sign which the man of God had given by the word of the Lord. And the king said to the man of God, ‘ Entreat now the favor of the Lord your God and pray for me, that my hand may be restored to me.’ And the man of God entreated the Lord, and the king’ s hand was restored and became as it was before.” (1 Kings 13:1– 6)

III. Tell-Tale Signs That an Evil Altar Has Been Judged by the Courts of Heaven!

- A. **The human attendant to the evil altar loses the power or ability to influence or control others using the evil altar' s voice.** That means that God silenced the voice of the evil altar. He made it mute and dumb in the spirit world as He did with the altar of Baal on Mount Carmel (1 Kings 18).

When the 400 prophets of Baal cut themselves with knives, hoping their sacrifice would make Baal speak on their behalf, but they were gravely disappointed.

- B. **Supernatural power shifted from the evil altar to the man of God.** When an evil altar is judged, its influence, power, and oppression over a person or family bloodline is broken permanently, and an increase of anointing, power, and authority takes its place.
- C. **God' s power splits the evil altar into pieces, making future use by anyone impossible.** That means that once an evil altar has been prosecuted and judged in the Courts of Heaven, its malicious activities in the believer' s life or family unit stops. I believe the exact opposite will begin to take place. For instance, if God judges an altar of poverty, then financial prosperity will start to flow freely in the lives of people who were previously bound by an evil altar of poverty.
- D. **The power of sickness and witchcraft are entirely broken.** God' s healing power is released to heal people previously infected by the evil altar!
- E. And this is my favorite: **God turns yesterday' s ashes into something beautiful when the ashes from the altar fall to the ground.** That is a prophetic picture of how God will restore the spiritual, emotional, and financial fortunes of people previously bound by the evil altar.

“ The Spirit of the Lord is upon Me, because the Lord has anointed Me ... to console those who mourn in Zion, to give them beauty for ashes, the oil of joy for mourning, the garment of praise for the spirit of heaviness; that they may be called trees of righteousness, the planting of the Lord, that He may be glorified.” (Isaiah 61:3)
